WHAT IS GPT?

- GPT stands for "Generative Pre-trained Transformer"
- It is a type of language model developed by OpenAI that uses deep learning techniques to generate human-like text.
- GPT models are trained on vast amounts of text data & they learn to predict the next word in a sentence based on the context of the preceding words
- The latest version of GPT as of my knowledge cutoff in 2021 is GPT-3
- It has 175 billion parameters and is currently one of the largest and most powerful language models available.

WHAT IS CHATGPT? (HTTPS://CHAT.OPENAL.COM/CHAT)

- ChatGPT is a state-of-the-art natural language processing model developed by OpenAI that is capable of generating human-like responses to natural language queries or prompts.
- It is based on the GPT (Generative Pretrained Transformer) architecture, which is a type of neural network designed for natural language processing tasks.

- ChatGPT was created by OpenAl, an Al and research company.
- The company launched ChatGPT on November 30, 2022.
- If the name of the company seems familiar, it is because OpenAl is also responsible for creating DALLE2, a popular Al art generator, and Whisper, an automatic speech recognition system.

HOW CHATGPT WORKS

- ChatGPT is a type of language model that can generate responses to natural language queries or prompts.
- It works by using a large neural network that has been trained on a massive corpus of text data from the internet.
- When given a prompt, ChatGPT generates a probability distribution over the next word in the response based on the context of the prompt.
- It then selects the word with the highest probability and uses it as the next word in the response.
- This process continues until the response is complete.

- Establish context
- Explain the topic
- Specify the task
- Ask follow-up question

- Replying to Department: There are many instances where the department seeks some documents or seeking adjournments or a simple one page reply is sufficient for the department and is more time consuming
- Drafting of Documents: ChatGPT can be used to draft documents such as NOC, Rent Agreement, Declaration, Undertaking etc.
- Finding Case Laws: ChatGPT can be used for finding case laws for your submission of reply to department
