GST: The “One Nation, One Tax” That Keeps Evolving

When GST was launched in July 2017, many breathed a sigh of relief. Gone (in principle) were the bewildering layers of VAT, excise, octroi, entry tax, and whatnot. The promise: a uniform, transparent, destination-based tax system that would simplify compliance.

But if you thought “one tax, done and dusted” — surprise! Like any self-respecting tax regime, GST must evolve. Enter **GST 2.0** in 2025 — the sequel, the remix, or the “Director's Cut” version.

The Ripple Effects (or: What Keeps a CA Up at Night)

Okay, so rates changed. But what does it *really* mean — especially for CAs, businesses, and the common consumer? Here are some juicy consequences (and comedic asides) worth pondering:

1. Winners vs Losers

- **Winner:** households, consumers — many everyday goods are cheaper now.
- **Loser:** some manufacturers or intermediaries who have “input costs taxed higher than output” issues (i.e., inverted duty structures).
- **Winner (or at least hopeful):** sectors like dairy, handicrafts, textiles, medical supplies, which got rate cuts.
- **Caution:** Some items, especially “luxury goods,” now may attract 18 % or even 40 % — putting pressure on pricing.

2. Cash Flow / Working Capital Stress

When inputs are taxed at the old (or higher) slab, but outputs move to a lower slab, the mismatch might squeeze margins or create refund burdens.

This is especially significant in **pharma**: APIs (active pharmaceutical ingredients) often still at higher rate, but finished drugs moved down.

3. Insurance / Agent Commission Drama

GST on life and health insurance has been made **exempt / nil**. But commissions to agents used to flow with full GST credits etc. Now, with this tweak, commissions might shrink due to GST inclusion. Some agents may grumble: “Hey I got 0% on the premium, but my take-home cut got taxed?” Indeed, that scenario is flagged in commentary.

4. Revenue Loss vs Growth Push

Yes, the government is likely to lose some revenue in the short run. Estimates suggest a net revenue loss of ~₹48,000 crore (after accounting extra from the new 40% slab) from the overhaul.

But that sacrifice is being pitched as an investment to stimulate **consumption** (which in turn generates growth, jobs, and eventually more tax base).

5. “Passing on the Benefit” Enforcement

One old bone of contention: when tax is cut, do businesses pass it to consumers or just pocket the extra margin? The government has warned against profiteering and indicated action if the benefit is not passed on.

6. Compliance / System Adjustments

Every CA and tax department now has to mess (er, *adjust*) with new classification, GST codes, return formats, transitional provisions, stock on hand valuations, etc. The devil is in the details (as always).

7. Inflationary / Deflationary Effects

Some analysts expect inflation moderation, because so many goods have cheaper tax components. Others warn of possible “snapping back” upward pressures in other sectors.

Advice (For Businesses) in This New Era

1. **Re-map your supply chain** — check whether your inputs / purchases now fall in mismatched slabs.
2. **Review contracts / pricing** — some customers may demand renegotiations.
3. **Watch ITC restrictions** — be extra cautious where ITC is disallowed or limited.
4. **Maintain detailed records / documentation** — for audits or anti-profiteering checks.
5. **Communicate with clients** — many will think “tax cut = price cut,” so be ready to explain which products benefit, which don't, and why.
6. **Transition rules are key** — handle stock on hand, old invoices, etc., carefully under transitional provisions.

7. **Keep an eye on refunds / cash flow** — sectors with inverted duty issues will particularly need attention to refunds or cash blockages.

In a Nutshell (Before You Flip the Page)

- The new phase of GST (GST 2.0) has simplified slabs, cut taxes on many household / essential goods, and introduced a steeper 40 % slab for luxury / sin goods.
- Consumers will welcome lower tax burdens on many items; businesses must brace for mismatches, refund stress, and compliance changes.
- The government is waving the “growth via consumption” flag while hoping the revenue loss is temporary and will be offset by a broader tax base later.

GST Input Tax Credit (ITC): Practical Challenges and the Way Forward

Introduction

The Goods and Services Tax (GST) regime was introduced in India with the objective of creating a seamless indirect tax system and eliminating the cascading effect of taxes. One of the most significant pillars supporting this objective is Input Tax Credit (ITC). ITC ensures that tax is levied only on value addition and enhances ease of doing business. However, despite being conceptually simple, ITC has emerged as one of the most litigated and compliance-intensive areas under GST.

This article aims to analyse the practical challenges faced by taxpayers in availing ITC and suggests a way forward to strengthen the GST framework.

Concept of Input Tax Credit under GST

Input Tax Credit refers to the credit of GST paid on the purchase of goods or services which can be utilised for payment of output tax. Section 16 of the CGST Act, 2017 lays down the eligibility conditions for availing ITC, which include:

- Possession of a valid tax invoice or debit note
- Receipt of goods or services
- Tax actually paid to the Government
- Furnishing of return under Section 39

While these conditions appear straightforward, their practical implementation poses several challenges.

Major Practical Challenges in Availing ITC

1. Dependency on Supplier Compliance

One of the most debated issues under GST is the restriction of ITC due to supplier non-compliance. If the supplier fails to file returns or deposit tax with the Government, the recipient may lose ITC despite fulfilling all obligations. This shifts the burden of ensuring supplier compliance onto the recipient, which is beyond their direct control.

2. Reconciliation Issues (GSTR-2B vs Books)

Mismatch between ITC as per books of accounts and

GSTR-2B has become a routine compliance concern. Differences may arise due to timing issues, amendments by suppliers, or clerical errors. Frequent reconciliations increase compliance costs and expose taxpayers to notices and interest liabilities.

3. Time Limit for Availment of ITC

The prescribed time limit for availing ITC — up to 30th November following the end of the financial year — often leads to genuine loss of credit due to delayed invoices or disputes. This rigid timeline undermines the principle that ITC is a vested right.

4. Blocked Credits under Section 17(5)

The provisions relating to blocked credits remain an area of ambiguity and litigation. Interpretation issues regarding business use, employee-related expenses, and capital goods often result in disputes with tax authorities.

5. Increased Litigation and Departmental Scrutiny

With continuous amendments, system-based restrictions, and data analytics-driven scrutiny, ITC claims are closely monitored by the department. This has resulted in a rise in notices, audits, and litigation, especially for genuine taxpayers.

Conclusion

Input Tax Credit is the backbone of the GST system and plays a crucial role in achieving tax neutrality. While the intent of the law is progressive, practical challenges continue to hinder its smooth implementation. Addressing these issues through policy reforms and administrative clarity will go a long way in strengthening taxpayer confidence and achieving the true objectives of GST.

As GST continues to evolve, a balanced approach between revenue protection and ease of compliance is essential to ensure sustainable growth and transparency in the indirect tax regime.

I'll try again.

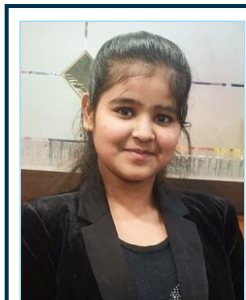
